Due notice to receive due care - Notice of Parental Rights to provide the law

Notice to Agent is Notice to Principal & Notice to Principal is Notice to Agent.

This document is being given as a notice for the receiving school district/charter school within the State of Arizona that have not complied with Arizona statute 15-249.16 "Statutory handbook of parental rights; posting" in its entirety INCLUDING placing the handbook of parental rights in a **PROMINENT** location of the website as laid out below.

I, one of the people of the state of Arizona as seen in Article 2 Section 2 of the Arizona Constitution am giving you this notice so that you and your agents provide due care. Per Arizona Constitution, ARTICLE 2. Section 1. "A frequent recurrence to fundamental principles is essential to the security of individual rights and the perpetuity of free government". Please take notice that as one of the people it is my duty to frequently provide the fundamental principles of law so that our rights shall remain secure.

See to it that Article 2 Section 3.B of the Arizona Constitution states "To protect the people's freedom and to preserve the checks and balances of the United States Constitution, this state may exercise its sovereign authority to restrict the actions of its personnel and the use of its financial resources to purposes that are consistent with the constitution by doing any of the following: 1. Passing an initiative or referendum pursuant to Article IV Part 1, Section 1 – 2. Passing a bill pursuant to Article IV, Part 2 and Article V, Section 7 – 3. Pursuing any other available legal remedy."

On the Fifth of June, 2020 during the Fifty-Fourth Legislative session for the state of Arizona, Governor Doug Ducey signed Senate Bill 1061 establishing **ARS 15-249.16**.

On the tenth of September, 2020 Superintendent of Public Instruction Kathy Hoffman provided the "Arizona Department of Education Parental Rights Handbook" stating "...(this statute) requires the Arizona Department of Education (Department) to establish and post a statutory handbook of parental rights. Additionally, each school district and charter school must prominently post a link to the statutory handbook of parental rights on a publicly accessible portion of their website" AND "In addition to posting on the Departments website, this document will be distributed to each public school for posting."

Therefore, it is required that all school districts/charter schools within the State of Arizona comply with ARS 15-249.16 IMMEDIATELY as described below AND as demanded by SPI Hoffman, the document will be distributed to each public school for posting:

"A. The department shall establish and post on its website a statutory handbook of parental rights that consists of the text of the following statutes: 1. Title 1, chapter 6 2. Section 15-102, Section 15-110, Section 15-113, Section 15-117, Section 15-351, Section 15-721, Section 15-722, Section 15-730.

B. Each school district and charter school in this state shall prominently post on a publicly accessible portion of its website a link to the statutory handbook of parental rights established pursuant to subsection A of this section."

Take note the Merriam-Webster definition of "prominent", 1: Standing out 2. Readily noticeable

Upon receiving this Notice, these adjustments must be made immediately.
